LIBRARY BOARD MINUTES

June 10, 2025

The regular meeting was called to order by President Roberta Mickelson @ 4:05 P.M.

Mr. Carney reminded the Board that a CD is due on 20Jun2025 and he will send Director Harte-Fischer current rates and terms to review. Harte-Fischer will poll the Board members by eMail to reach consensus on renewal term and rate.

Draft minutes from May 13, 2025 meeting were reviewed and motion to accept was made by Harmon, seconded by Abbott and passed unanimously. Final minutes will be posted on library website by Harte Fischer.

Treasurer Update:

Budget update and bills paid were provided by Treasurer Skofich. Expenditures for the month were in line with projections. Harmon motioned for bills to be paid as presented, seconded by Gresk and approved unanimously. Gresk and Harmon reviewed and initialed paper copies of the monthly bills listing.

Treasurer Skofich and Director Harte-Fischer are working on the draft budget for FY 2025/6. It was noted that with changes occurring to state and federal funding, the status of grants usually applied for is in question and need to be accounted for in the planning. Draft budget will be available for the Board to review at the July Board meeting.
